RULES

- (i) All surviving puppies of the litter must be registered at the same time on the same form. For part litters use **Form No. 1**.
- (ii) Puppies must be under the age of three months at the date of receipt of application for registration, correctly completed, otherwise, **Forms 1** must be completed.
- (iii) The sire and dam must be registered with The Irish Kennel Club Ltd., or the sire registered with another recognised Kennel Club.
- (iv) Separate names should be used for each puppy. Not more than two dogs may be registered with the same Prefix/Affix by one applicant. Should it be desired to use the word on three or more occasions, it will require to be registered as a Prefix/Affix. Alternative names should be noted on a separate sheet of paper, and attached. In order to avoid confusion with names already registered, The Irish Kennel Club Ltd., reserves the right to alter any name selected, without reference to the applicant.
- (v) From 1st January 2011 The Irish Kennel Club will not accept individual applications for registration/transfer from minors under the age of 16 years.
- (vi) All puppies must be microchipped.
- (vii) All services of The Irish Kennel Club Ltd., are confined to Associate Members only.

CAUTION: A SIGNATURE FORGED OR SIGNED BY ANOTHER PERSON WILL CAUSE THIS APPLICATION TO BE REJECTED AND THE SUSPENSION OF ANY FURTHER REGISTRATIONS FROM THE APPLICANT.
