## Microchipping of Dogs Regulations 2015

The Irish Kennel Club CLG is authorised under Section 5 of the above regulations to operate a Dog Identification Database. On registration, the information on this form will be entered into the Dog Identification Database and the Irish Kennel Club will send to the Veterinary Practice/ Implanter a Registration Summary for their records. The Breeder, as the registered owner of the dogs, will be sent the Registration Certificates and a Registration Summary.

I/We Hereby Declare to the best of My/Our knowledge, information and belief, that this pedigree is true and accurate in its details and I/We Hereby AGREE to abide by the decision of The Irish Kennel Club CLG, which shall be final, upon any question in relation to this pedigree and to the publication of any proceedings or decisions in reference thereto.

I/We agree to be bound by the Rules and Regulations and the Code of Ethics of THE IRISH KENNEL CLUB CLG.

I/ We agree that THE IRISH KENNEL CLUB CLG may release my/our contact details to an authorised third party under Schedule 1.2 of the Microchipping of Dogs Regulations 2015.

I/We FURTHER AUTHORISE THE IRISH KENNEL CLUB CLG. to record the information on this form on the Irish Kennel Club approved Dog Identification Database in accordance with Section 5 of the Microchipping of Dogs Regulations 2015.

## ABRIDGED RULES GOVERNING REGISTRATION

1. The Declaration on each application for registration must be signed by the breeder, this signature to be considered as endorsement of its correctness. In certain cases, where the signature of the breeder cannot be procured, the Irish Kennel Club CLG, may, upon proper application, waive this requirement, subject to the production of such evidence as it may require.
2. As the duplication of names is not permitted, you are requested to state your first, second and third choice. The Irish Kennel Club CLG reserves the right to alter a letter or word in the name applied for in case of duplication, likely confusion or other reason thought fit.
3. Not more than two dogs may be registered with the same prefix/affix by the breeder, or from the same litter. Should it be desired to use the word on three or more occasions it will be required to be registered as a prefix/affix.
4. No change or addition of any sort will be permitted in the registered name of a dog, except by the addition of a registered prefix/affix.
5. (a) All dogs whelped within the jurisdiction of the Irish Kennel Club CLG must be registered by the breeder.  
(b) Applications for registration shall be made on the form prescribed, duly signed by the breeder.  
(c) The breeder is the registered owner or registered lessee of the dam at the date of whelping.
6. (a) Registration of dogs, litters, kennel names, owners, transfers, pedigrees, etc., shall be subject to such documented information being furnished as the Secretary of the Irish Kennel Club CLG may consider necessary in the particular case in addition to the name and address of the owner, breeder, and owner of Sire, colour and markings and date of birth.  
(b) The Irish Kennel Club CLG may require any dog to be certified as being suitable for registration.
7. All Services of the Irish Kennel Club CLG are confined to Associate Members only.
8. All DOGS must be microchipped in accordance with the Microchipping of Dogs Regulations 2015.

## FOR YOUR INFORMATION

Registration is confined to:

- (a) Dogs whelped in Ireland whose parents are registered with the Irish Kennel Club CLG.
- (b) Dogs whelped in Ireland where the dam is registered with the Irish Kennel Club CLG and the sire is registered with another recognised Kennel Authority.
- (c) Dogs whelped outside the jurisdiction of the Irish Kennel Club CLG if registered with a recognised Kennel Authority. Form OS1 required.
- (d) Extraneous applications, e.g. not covered in (a), (b) or (c) above, must be considered for approval by the General Purposes Committee.
- (e) Subsequent changes/corrections must be made to IKC within 7 days and will incur administration charge.

The Irish Kennel Club will not retain credit card information subsequent to processing payment.

## Two Tier Registration System & Pet Register.

### Main Register

Full Pedigree Dogs  
IKC Certified  
Can be bred from  
Can be Exported

### Limited Register

Full Pedigree Dogs  
IKC Certified  
Cannot be bred from  
Not for Export

### Pet Register

Non Pedigree Dogs  
IKC Certified / Non Pedigree

- Breeder can opt for Main or Limited Register **provided it fits Breed Standards.**
- Dogs of Non Standard Colours automatically go on the Limited Register.
- Limited Registration can be changed to Full Registration only by written request from the Breeder.
- Dogs stay on the register regardless of any change of ownership, unless, and until, the Breeder applies for a change.
- Each Registration Certificate will be clearly identified with Main, Limited or Pet.
- Limited Registration helps Breeders protect their breeding programs.
- The IKC will not become involved in disputes concerning "Full" or "Limited" registration of a dog. These disputes must be resolved by the parties involved in the sale of the dog
- The Breeder must make the buyer fully aware of the Register the puppy is on.
