## ABRIDGED RULES GOVERNING REGISTRATION

1. The Declaration on each application for registration must be signed by the applicant (or his agent), this signature to be considered as endorsement of its correctness.
2. When applying for the registration of a dog already registered with any kennel club recognised by the Irish Kennel Club CLG
  - (a) the registered name of the dog must be retained, but if such name is similar to, or likely to be confused with one already registered with the Irish Kennel Club CLG the name shall on all occasions, be followed by an abbreviation for the name of the country in which the dog is registered;
  - (b) the certificate of registration, and, if applicable, the certificate of transfer in the owner/s name/s issued by the appropriate kennel club must be submitted to the Irish Kennel Club CLG for inspection when registration is applied for.
3. All dogs imported from outside Ireland must be identified by Microchip number and the official documentation supplied to us for inspection. Under Section 3 of the Microchipping of Dogs Regulations 2015, a microchip implanted into a dog must generate an International Committee for Animal Recording (ICAR) certified unique code and comply with ISO Standard 11784, applies FDX-B technology and is capable of being read using a reading device compatible with ISO Standard 11785. To check the validity of a microchip number login to [www.dvc.services](http://www.dvc.services) and enter the microchip number. If the microchip is not valid please ask your Veterinary Surgeon to implant a compliant microchip as we cannot register a dog unless it has a valid microchip number.
4. No change or addition of any sort will be permitted in the registered name of a dog, except by the addition of a registered prefix/affix.
5.
  - (a) The applicant, if resident in Ireland, must be an associate member of the Irish Kennel Club CLG
  - (b) Applications for registration shall be made on the form prescribed, duly signed by the owner, or the agent of the owner, where appropriate.
  - (c) Registration of dogs, litters, kennel names, owners, transfers, pedigrees, etc., shall be subject to such documented information being furnished as the Secretary of the Irish Kennel Club CLG may consider necessary in the particular case in addition to the name and address of the owner, breeder, and owner of Sire, Pedigree to 3 generations, colour and markings and date of birth.
  - (d) The Irish Kennel Club CLG may require any dog to be certified as being suitable for registration.

The Irish Kennel Club will not retain credit card information subsequent to processing payment.
